General Description

The LCX11 is a triple 3-input AND gate with buffered outputs. LCX devices are designed for low voltage (2.5V or 3.3V) operation with the added capability of interfacing to a 5V signal environment.

The 74LCX11 is fabricated with advanced CMOS technology to achieve high speed operation while maintaining CMOS low power dissipation.






Pin Assignments for SOIC, SOP, and TSSOP




Logic Symbol






Figure 1. AC Test Circuit (C_L includes probe and jig capacitance)




Waveform for Inverting and Non-Inverting Functions




3-STATE Output High Enable and Disable Times for Logic




Propagation Delay, Pulse Width and t_{rec} Waveforms

3-STATE Output Low Enable and Disable Times for Logic





Schematic Diagram (Generic for LCX Family)




Figure 3. 14-Lead Small Outline Integrated Circuit (SOIC), JEDEC MS-012, 0.150" Narrow






Figure 4. 14-Lead Small Outline Package (SOP), EIAJ TYPE II, 5.3mm Wide


Figure 5. 14-Terminal Depopulated Quad Very-Thin Flat Pack No Leads (DQFN), JEDEC MO-241, 2.5 x 3.0mm
