



These voltage references can be used to make portable meters, regulators, or general-purpose analog circuitry, with battery life approaching shelf life. The wide operating current range allows them to replace older references with tighter-tolerance parts.






Figure 10. Thermocouple Cold-Junction Compensator




Figure 11. Operation Over a Wide Supply Range




Figure 12. Reference From a 9-V Battery





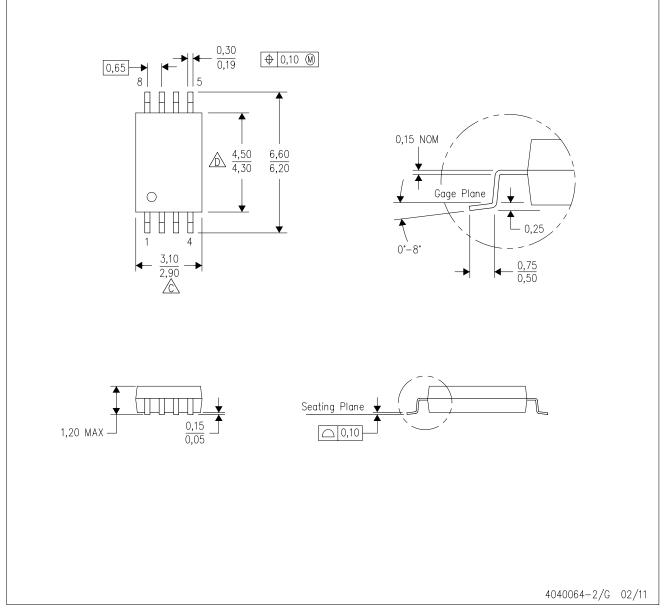
