



Figure 1. On-Region Characteristics




Figure 2. Transfer Characteristics




Figure 3. On-Resistance Variation vs. Drain Current and Gate Voltage




Figure 4. Body Diode Forward Voltage Variation vs. Source Current and Temperature




Figure 5. Capacitance Characteristics





Figure 6. Gate Charge Characteristics

Figure 7. Breakdown Voltage Variation vs. Temperature




Figure 8. Maximum Safe Operating Area - FDP5N50U




Figure 9. Maximum Safe Operating Area - FDPF5N50UT




Figure 10. Maximum Drain Current vs. Case Temperature






Figure 11. Transient Thermal Response Curve - FDP5N50U




Figure 12. Transient Thermal Response Curve - FDPF5N50UT




Gate Charge Test Circuit & Waveform





Resistive Switching Test Circuit & Waveforms
